**A BILL**

To require heads of Executive agencies to, upon request, submit to relevant congressional committees information regarding the furlough or indefinite suspension without pay of employees of such Executive agencies, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Requiring Officials and  
5       Bureaucrats to Expeditiously Relinquish Testimony and  
6       Meaningful Answers about Lawbreaking and Locked out

1 Employees Yesterday Act” or the “ROBERT MALLEY  
2 Act”.

3 **SEC. 2. SENSE OF CONGRESS.**

4 It is the sense of Congress that—

5 (1) the government of the United States must  
6 be transparent with the American people and with  
7 Congress;

8 (2) the Executive Branch should never obstruct  
9 the right of Congress to investigate and conduct  
10 oversight;

11 (3) individuals that conspire with State Spon-  
12 sors of Terror or foreign terrorist organizations  
13 should be held accountable to the fullest extent of  
14 the law; and

15 (4) individuals that knowingly hire, or attempt  
16 to convince others to hire, intelligence assets for for-  
17 eign nations are guilty of treason.

18 **SEC. 3. FURLOUGH AND INDEFINITE SUSPENSION EXPLA-**  
19 **NATIONS.**

20 (a) IN GENERAL.—Not later than 15 days after the  
21 head of an Executive agency receives a request from the  
22 Chairman or Ranking Member of an appropriate congres-  
23 sional committee for an explanation why an employee of  
24 such Executive agency was furloughed or suspended in-  
25 definitely without pay, such head of an Executive agency

1 shall submit to the Chairman or Ranking Member making  
2 such request an explanation of the reasoning for such em-  
3 ployee being furloughed or suspended indefinitely without  
4 pay, including any relevant information and evidence col-  
5 lected in the course of an investigation prior to interven-  
6 tion by a law enforcement agency.

7 (b) EXCLUSIONS.—Subsection (a) shall not apply  
8 with respect to employees—

9 (1) suspended or furloughed pursuant to an ac-  
10 tion initiated under section 1215 of title 5, United  
11 States Code; or

12 (2) furloughed as a result of a lapse in appro-  
13 priations.

14 (c) FORM.—An explanation required by subsection  
15 (a) shall be in an unclassified form, but may contain a  
16 classified annex.

17 (d) DEFINITIONS.—In this section:

18 (1) APPROPRIATE CONGRESSIONAL COMMIT-  
19 TEES.—The term “appropriate congressional com-  
20 mittees” means—

21 (A) the Committees of the Senate and  
22 House of Representatives with jurisdiction over  
23 the Executive agency;

1                   (B) the Committee on Oversight and Ac-  
2                   countability of the House of Representatives;  
3                   and

4                   (C) the Committee on Homeland Security  
5                   and Governmental Affairs of the Senate.

6                   (2) EXECUTIVE AGENCY.—The term “Executive  
7                   agency” has the meaning given such term in section  
8                   105 of title 5, United States Code.
